# GENERAL RENTAL CONDITIONS 2025

### 1 - Registration

All registration must be accompanied by a advance payment of 30% + 20 $\odot$  of application fees.

## 2 – Length of stay

From 05 July to 30th August 2025, for a better organization of our management and in the interest of our customers, the duration of the booked stay is 2 nights minimum for a pitch and 7 days minimum for a Privilege pitch. Arrivals are made after 14 hours and departures before 12 hours.

Your reservation is considered final as soon as it has been confirmed by us. You will have to pay the balance on the day of your arrival at the campsite. Any changes must be reported upon arrival.

**4 - The number of participants** It may not be modified under any circumstances without the written consent of the Management. The Management reserves the right to refuse these persons, including

b - Cancellation of stay

1. Change to your booking:

Changes to your reservation can be made free of charge, subject to availability. Any modification of the dates of stay must be handwritten and only for the current season.    Less than 30 days before the start date of stay: 100% of the amount of the stay will be kept by the campsite.

A deposit of €100 (for bare pitches) and €235 (for privileged pitches) will be requested at the beginning of your stay. This deposit includes the breaking of the equipment on the campsite and the cleanliness of the site equipment on the campsite and the cleanliness of the site at your departure (garbage cans, canine droppings, etc.) as well as the loan of equipment (golf clubs, etc.) and compliance with the campsite's internal regulations. It will be returned to you no later than eight days after your departure, after deduction if necessary. At the end of the stay, the plot must be returned in perfect cleanliness, otherwise the sum minimum of 25€ will be deducted from the density. the deposit.

## 7 - Pets

Your pet of less than 6 kg is accepted except the dogs of 1st and 2nd category for a fee payable on your reservation. When authorized, they must be kept on a leash at all times. The vaccination record for dogs and cats must be up to date and presented on the day of arrival, tattoo required. Under no circumstances should they remain alone on the plot.

## 1 - Registration

All registration must be accompanied by the payment of the deposit of 30% of the price of your rental + application fee 20€.

## 2 – Length of stay

Between the 5th of July to 30th of August 2025 the minimum stay is 7 days. The date of arrival is to be specified in the booking (Wednesday, Saturday or Sunday). The availability of the date will be confirmed. Arrivals are from 4 pm to 8 pm (in case of delay, please let

Departures are from 10 am at the latest.

**3 - Booking** Your reservation is considered final as soon as it has been confirmed by us. You will have to pay the balance by mail or phone 30 days before your arrival on the site, otherwise the reservation may be considered cancelled and the deposit kept.

## 4 - The number of participants

It must correspond to the number of people indicated on the booking form, including children. Management reserves the right to refuse surplus persons.

## 6 – Deposit

A deposit from €370 to €415 will be requested at the beginning of your stay. This deposit includes the breakage of the equipment and the cleanliness of the accommodation at your departure as well as the loan of equipment (golf clubs, etc.) and compliance with the campsite's internal regulations. It will be returned to you no later than eight days after your departure, possibly deducted from the cost of the missing equipment. Cleaning is the responsibility of the tenant. At the end of the stay, the rental must be returned in perfect cleanliness, otherwise a minimum of 70€ will be deducted from the deposit...

## 7 -Pets

Your pet under 6 kg is accepted, depending on the mobilhome model, except for dogs of 1st and 2nd category for a fee payable at the time of booking. When authorized, they must be kept on a leash at all times. The vaccination record for dogs and cats must be up to date and presented on the day of arrival, tattoo required. Under no circumstances should they remain alone on the plot or in the mobile home.

## 1 - Rules of procedure

In order to facilitate the development of your holidays, a rules of procedure is at your disposal at the reception desk. We thank you for reading it and respecting it.

## 2 – Responsability

SAS SE HARAS is not liable for loss, theft, damage of any kind, during or following a stay. The Directorate is only responsible for items deposited in the office. Civil liability insurance is mandatory.

# 3 – Tourist tax

Tourist taxes, imposed by the municipalities, are not included in our rates.

Rates are inclusive of VAT with a VAT rate of 10% applicable on the day the rates were determined. Any subsequent change in the applicable VAT rate, occurring between the time the rates were determined and the billing of the stay, will result in a consequential change in the TTC price, which the customer accepts without reservation.

## 5 - Cancellation insurance

Les Jardins du Morbihan campsite offers Cancellation Insurance in your rental contract. In case of cancellation, notify the campsite of your withdrawal as soon as an event occurs preventing your departure by mail or email. If the loss is foreseen in the general conditions (available on site or at the campsite), inform the campsite within 48 hours and provide all necessary information and supporting documents.

## 7 - Aquatic area

Swim shorts and loose clothing are not allowed in our aquatic area.

You authorize La SAS SE Haras, as well as any person that SAS SE Haras would like to replace, to photograph, record or film you during your stay at Camping Les Jardins du Morbihan in Monterblanc and to exploit the said images, sounds, videos and recordings on all media (especially on the websites or Internet pages of Camping Les Jardins du Morbihan – including facebook –, on the presentation and promotion materials of Camping Les Jardins du Morbihan and on travel or tourist guides).
